


Directions to Training

Club Signs Will Be Out

Hampton Estate Dairy Farm/Myrtle's Courtyard GU10 1JE

From the A31 Hog's Back, take signs to Puttenham where you turn left into Suffield Lane opposite the Good Intent pub.

At the T-junction, turn right into Littleworth Road and approach from the south side of



the estate, taking the lane off Littleworth Road towards the house and estate office. Signs will be out from this turning.

Sweetwater GU8 5SR



From the A3, take the exit into Milford.

In Milford, turn left at the second traffic lights, continue to the roundabout and take the second exit signposted Petworth A283.

After Witley, pass the White Hart, go down a hill and turn left into Culmer Lane just past a post box.

Continue under the railway bridge to the ground situated immediately before the lake through a gate on your right.

The red square marks the spot; Club signs will out.

Heading North on the A283 go past King Edward's School and at the bottom of the hill turn right into Culmer Lane.

At the A3 Milford roundabout take the B3001 towards Elstead. After about a mile, on the right-hand side, you will see white rings on two trees either side of the entrance to a drive which leads to Deerbridge House.

From Farnham, come through Elstead Village. Continue to Deerbridge House on the left.

Equipped with our rather fetching and broadly admired team shirts (well chosen by Jean Baveystock) we made a good start with Test 1 (judged by Brian Kent). Three blinds down a track at different distances, the Open one being quite a challenge across a pond into thick cover. Peter and Skye did particularly well delivering one of the two best performances on that test, according to the judge.

Test 2 (judged by Gwen Butcher) required a quick team decision. As ND/NH I chose the second mark across the field as first retrieve. Then Gerry Price's Sunny faced the challenge of finding the first mark in water surrounded by high grass barely visible from where we stood.

Test 3 (judged by Ron Jeffrey) was over water again, a mark across a small pond for the ND/NH to be picked first followed by a blind for the Novice in reeds further back, whilst the Open retrieve was a blind along the lake. All dogs performed well on this test which wasn't easy in any category.

Test 4 (judged by Jane Tydeman) was the much dreaded walk-up with three marks (with shot) in very high grass.

At Test 5 (judged by Graham Stanley) Toby and I were third to go on a mark with two shots down a steep slope on to a lake. The Open dog did well retrieving a blind across the water then the Novice had a blind on a bank to the right. Thankfully Toby remembered that dummy in the lake and brought it back safely

All in all we were quite happy with our performances and were certainly very pleased to come third. Toby was the highest scoring dog and the Judges' Choice. We also won Best ND/NH so that was the icing on the cake. Quite a good day after all. It must have been those shirts!

Thanks to Guildford Working Gundog Club for giving us the opportunity to represent the Club at this grand event. What an honour and pleasure it was.

Report of our 2012-2013 Season Trials

Novice, Knowle Hill Game Farm, 11th October

(see pg 12 for results)

Karen Pinker writes: Birds came quickly to hand at the Guildford Novice Retriever stake at Knowle Farm, Kent. Guns shot extremely well, often bringing several birds down at once which made marking virtually impossible and which became the downfall of some of the earlier dogs.



Light drizzle persisted throughout the day and leggings were compulsory in the well grown crops. Walked up trials do not come much better than Knowle Farm and the four judges Robin Watson, Ezio Venturi, Rodger Ketley, Alan Buckland were kept busy.

There was a high standard of dog work and as the trial progressed 4 dogs were taken forward to the final round having retrieved 5 birds each. A partridge had apparently been shot in the large field of crop unseen by the judges or competitiors. The dogs were called in numerical order and requested by the judges to hunt the area as a picking up exercise. The first 3 dogs sent all hunted well in a given time but were eventually called up. The last dog to go was Olivertash Mavis, "the next victim" were Robin Watson's words. With the wind crossing from left to right, Mavis hunted the area slightly further to the right and was rewarded with a find of the elusive partridge which brought the trial to an end.

This was a superb trial in challenging conditions. Grateful thanks to Stephen King for allowing us to use the ground, to the judges and the excellent team of guns along with Guildford Working Gundog Club for all your sterling hard work.


Special Puppy, Deerbridge, Elstead, 22nd April

Club Rules

1. NAMES & OBJECTS

The Club shall be called Guildford Working Gundog Club. Its objects shall be to promote and encourage the training of gundogs for work in the field and to organise training classes, working tests and field trials.

2. OFFICERS & COMMITTEE

The Club shall consist of a President, Chairman, Hon Secretary, Hon Treasurer and Field Trial Secretary, a Committee of 12 and an unlimited number of members.

3. COMMITTEE

The management of the Club shall be in the hands of the Officers of the Club and a Committee consisting of 12 members, all of whom shall retire annually but shall be eligible for re-election.

Meetings of the Committee shall be held as often as deemed necessary and a quorum for Committee meetings shall be 5.

The Committee shall have the power to appoint sub-committees as it deems necessary. The Chairman of each sub-committee shall be on the general Committee and report the sub-committee's recommendations to the general Committee.

4. ELECTION OF MEMBERS

Candidates for membership shall be proposed by two existing fully paid up members and approved by the Committee.

5. MEMBERSHIP LIST

The Club must make a list of members and their addresses available for inspection if so requested by the members of the Society or by the Kennel Club.

6. CLUB PROPERTY

The property of the Club shall be vested in the Committee. In the event of the Club ceasing to exist a General Meeting shall be called to decide the disposal of the Club's assets and the outcome of the meeting notified to the Kennel

The Club will obtain written acknowledgements from donors of Cups and Trophies that they are given as outright gifts to the Club.

7. CLUB ACCOUNTS

A Bank Account and a Building Society Account shall be opened in the name of Guildford Working Gundog Club into which revenue of the Club shall be paid and from which withdrawals shall be made on the Chairman, Hon Secretary and the Hon Treasurer's signatures (any two). The accounts shall

be kept by the Hon Treasurer and Auditors shall be appointed at each Annual General Meeting who shall audit the Club Accounts for the Annual General Meeting.

NOTE: Certification of Accounts must be carried out by one qualified accountant or two unqualified individuals with accountancy experience.

8. SUBSCRIPTIONS

The annual Subscription and a one-off Membership fee shall be such an amount as agreed by members in General Meeting and notified to the Kennel Club. No member whose subscription is unpaid is entitled to any of the privileges of membership and if the member shall fail to pay outstanding subscriptions by the end of April, his or her name shall be automatically erased from the register. If a membership lapses then a new membership fee shall be required on rejoining.

9. EXPULSION OF MEMBERS

Any member who shall be suspended under Kennel Club Rule A42j(4) and/or any member whose dog(s) are disqualified under Kennel Club Rule A42j(8) shall *ipso facto* cease to be a member of the Society for the duration of the suspension and/or disqualification.

If the conduct of any member shall in the opinion of the Committee of the Club be injurious or likely to be injurious to the character or interests of the club, The Committee of the Club may, at a meeting the notice convening which includes as an object the consideration of the conduct of the member, determine that a Special General Meeting of the Club shall be called for the purpose of passing a resolution to expel him/her.

Notice of the Special General Meeting shall be sent to the accused member, giving particulars of the complaint and advising the place, date and hour of the Meeting that he/she may attend and offer an explanation. If at the Meeting, a resolution to expel is passed by a two-thirds majority of the members present and voting, his/her name shall forthwith be erased from the list of members and he/she shall thereupon cease for all purposes to be a member of the Club except that he/she may, within two calendar months from the date of such a meeting, appeal to the Kennel Club upon and subject to such condition as the Kennel Club may impose.

10. FINANCIAL YEAR/ANNUAL GENERAL MEETING

The financial year of the Club shall be from 1st February to 31st January. The Annual General Meeting shall be held in March.

11. GENERAL MEETINGS

The Annual General Meeting shall be held for the following purposes: To receive and approve the report of the Chairman on the activities of the past year.

To receive and approve the Accounts for the past year.

To elect the officers and Committee for the ensuing year.

To transact any other business on the Agenda.

No other business shall be transacted at the Annual General Meeting unless notice thereof appears on the Agenda, with the exception of routine matters or those which in the opinion of the Chairman of the Meeting are urgent. Any member wishing to have any other matter placed on the Agenda must inform the Hon Secretary in writing 14 days before the date of the Meeting. Notice convening such a Meeting will be forwarded to every member not less than 28 days prior to the date of the holding of the Meeting.

12. SPECIAL GENERAL MEETINGS

A special General Meeting shall be summoned by the Hon Secretary if six members send a signed requisition stating the subject to be discussed and requesting a Special General Meeting to do so.

No business other than that detailed on the Agenda can be discussed at a Special General Meeting. The Committee is empowered to call a Special General Meeting at its discretion. The following method of notifying members of a special General meeting will apply. In writing with 14 days notice of the Meeting.

13. AMENDMENTS TO THE CONSTITUTION

The Rules of the Club may not be altered except at a General Meeting, the Agenda for which contains specific proposals to amend the Rules. Any proposed alteration to the Rules may not be brought into effect until the Kennel Club has been advised and approved the alteration.

14. ANNUAL RETURNS TO THE KENNEL CLUB

The officers acknowledge that during the month of January each year, maintenance of Title Fee will be forwarded to the Kennel Club by the Secretary for continuance of Registration and that by 31st July each year, other returns, as stipulated in Kennel Club Regulations for the Registration and maintenance of Title of Societies and Breed Councils and the Affiliation of Agricultural Societies and Municipal Authorities be forwarded to the Kennel

The Officers also acknowledge their duty to inform the Kennel Club of any changes of Secretary of the Club which may occur during the course of the year.

15. KENNEL CLUB FINAL COURT OF APPEAL

The Kennel Club shall be the final court of appeal in all matters of dispute. The Society shall not join any Federation or Societies or Clubs

No person whilst an undischarged bankrupt may serve on the Committee of or hold any other office or appointment within a Kennel Club Registered Society.
